

Conditions of participation opti trend radar sweepstakes

These terms and conditions apply to participation in the prize draw for the current opti Trend Radar survey (starting on 27.7.2023 and ending on 30.9.2023 at 23:59) at the opti trade fair. The raffle is organized by GHM Gesellschaft für Handwerksmessen mbH (hereinafter referred to as "GHM"), Paul-Wassermann-Str. 5, 81829 Munich, Germany.

Natural persons who have reached the age of 18 are eligible to participate. Participation in the prize draw for 1) a free ticket to opti 2024 for every 3rd draw, 2) a free ticket to opti 2024 including an invitation to the VIP lounge with a drinks voucher for every 10th draw and 3) free tickets to opti 2024 for the entire company for every 50th draw is free of charge and voluntary and not dependent on the purchase of products and services.

Employees of GHM and persons entrusted with the implementation of the prize draw as well as their respective relatives are not eligible to participate. In addition, GHM reserves the right, at its own discretion, to exclude persons from participation if there are justified reasons, e.g.

- a) in the event of manipulation in connection with the implementation of the prize draw,

GHM will inform the winners by e-mail by 6.11.2023 at the latest. The prize will be sent to the winner's e-mail address by ticket code. The drinks voucher will be handed over directly in the VIP lounge. The winner is responsible for any taxation. The participant is responsible for the correctness of the contact details provided. If it is not possible to allocate a prize due to incorrect or incomplete information, the claim to the prize shall be forfeited.

GHM takes the protection of personal data seriously and complies with the relevant data protection regulations. You can view our applicable data protection regulations at www.ghm.de/datenschutz. Participation in the prize draw requires the provision of personal data. The participant

assures that the personal data provided, in particular first name, last name and e-mail address, are his/her own and correct. The collection and processing of personal data is used exclusively for the implementation of the competition and, if necessary, to send the prizes. All data will be stored only for the purpose and for the duration of the competition and will be deleted at the end of the campaign, unless there is a legal obligation to keep records. The personal data of the participants will neither be passed on to third parties nor given to them for use without their consent.
